#### Public Feedback Period on Proposed Revisions to FHA's Defect Taxonomy Extended to June 30, 2019

Today, the Federal Housing Administration (FHA) announced that it will extend the public feedback period on its proposed revisions to the Defect Taxonomy posted on the [Single Family Housing Drafting Table](#) (Drafting Table) on [hud.gov](http://hud.gov) until 11:59 PM (Eastern) on June 30, 2019. The original feedback end date was June 8, 2019.

The proposed revisions to the Defect Taxonomy were previously announced in [FHA INFO 19-18](#) on May 9, 2019.

FHA is extending the feedback period to give interested parties additional time to review and submit feedback on the proposed changes. The feedback deadline for the Annual Lender Certifications — also posted on the [Drafting Table](#) — remains the same, and ends on June 8, 2019.

On May 30, 2019, the feedback deadline for the *Addendum to Uniform Residential Loan Application* (Form 92900-A, loan-level certification) was extended to June 30, 2019, as announced in [FHA INFO 19-27](#).
